

## DATA PROTECTION DECLARATION

The English version of the Data Protection Declaration is not binding and for convenience and information purposes only. In all cases, the German language version prevails.

We, EOS – Events & Services GmbH, collect, store and use your personal data according to the provisions of data protection laws, particularly the German Federal Data Protection Law and the Telemedia Law. This declaration serves to give you an overview of the types of data we process, for which purposes we process them and the rights you are entitled to.

#### §1 Anonymized data collection and processing at this website

Data transmitted by your browser are automatically collected and stored in an internal log file on our server.

This includes the following data:

- type and version of the browser you use,
- type and version of the operating system you use,
- URL of the site from which you made connection with our site,
- search terms used to find our site,
- date and time you accessed our site,
- name of the subpages you accessed.

We collect and store these data in an anonymized form, i. e. they may not be related to a specific person. The data are collected and processed to be evaluated for internal system-related and statistic purposes.

## §2 Use of your data

We use your email address to complete registration at our website by sending you a confirmation email and to submit confirmation emails to you concerning the orders you have placed.

We will not use your email address for our newsletter or other offers that may be of interest to you, unless you have given us your consent to do so. You may cancel your consent to receiving newsletters and emails from our company at any time. Further details on your right of objection are specified below under "Right of objection and cancellation".

You may object to a corresponding use of your data at any time by sending us a short message to one of the addresses stated below.

Customer data are not passed on to unauthorized third parties.

# §3 Cookies

We use so-called cookies on our website. Cookies are small text files which are sent to your browser and stored on your computer. By placing cookies, our server is able to identify your browser, your individual settings on our webpages and, if applicable, parts of your log-in data in encoded form to ease navigation through our pages and let you log in automatically.

You may change your browser's settings to reject cookies, delete them from your computer, block them or to be prompted each time a cookie is offered. The cookies placed by us are deleted from your computer after each session.

# §4 Right to information, correction, blocking and deletion of data

Upon request and at all times we will provide you with free information on your personal data stored, their origin, the recipients, as well as the purpose of data storage. This information can be obtained from us using the contact details stated below.

In case the legal conditions are given, you have the right to correction, blocking or deletion of these data. Again, please refer to the contact details stated below.

## §5 Right of objection and cancellation

You have the right to object to the use of your data for the generation of user profiles and to cancel the consents you may have given us. In this case, we will refrain from processing your data for these purposes. The objection or cancellation may be submitted to us in an informal letter, fax or email without stating a reason.
